

2026/2027 ASC Board Member/Staff Statement of Faith



As a person of faith and an ASC board member, I believe:

The Scriptures, both Old and New Testaments, to be the inspired Word of God, without error in the original writing, the complete revelation of His will for the salvation of mankind, and the Divine and final authority for all Christian faith and life. *2 Timothy 3:15-17; 1 Thessalonians 2:13; 2 Peter 1:21*

In one God, creator of all things, infinitely perfect and eternally existing in three persons, Father, Son and Holy Spirit. That Jesus Christ is the son of God and the son of man, having been conceived of the Holy Spirit and born of the virgin Mary. *Luke 1:26-38*

Jesus Christ died on the cross, a sacrifice for our sins according to the Scriptures. Further, he arose bodily from the dead, ascended into heaven where at the right hand of the Father on High, He is now our High Priest and Advocate. *John 1:1-3; 1 Corinthians 8:4; Romans 16:26; Colossians 1:16-17, 2:3; Hebrews 1:1-3, 9:14; 2 Peter 3:9; Revelation 1:8, 4:11*

That the ministry of the Holy Spirit is to glorify the Lord Jesus Christ, and during this age to convict men, regenerate the believing sinner, indwell, guide, instruct, and empower the believer for Godly living and service. *John 16:12-15, Ephesians 1:13-14, Galatians 5:22-23*

That mankind was created in the image of God but fell into sin and is therefore lost and only through regeneration by the Holy Spirit can spiritual life be obtained. *Genesis 1:27-28*

That the shed blood of Jesus Christ and His resurrection provide the only ground for justification and salvation for all who believe, and only such as receive Jesus Christ are born of the Holy Spirit, thus become children of God. *John 3:3, Romans 8:14*

That water baptism and the Lord's Supper are ordinances of God to be observed by the Church during this present age. They are, however, not to be regarded as means of salvation. That the true Church is composed of all such persons who through saving faith in Jesus Christ have been regenerated by the Holy Spirit and are united together in the body of Christ of which He is head. Matthew 3:11: "I baptize with water those who repent of their sins and turn to God". *Matthew 28:19, Acts 2:38, Acts 22:16*

We believe that all human life is sacred and created by God in His image. All human life, from conception to natural death—including pre-born babies, the aged, and the physically or mentally challenged—holds immeasurable value and dignity. We are therefore called to defend, protect, and value all human life. *Gen. 1:26-27, 9:6; Psalm 139; Matt. 9:36, 14:14, 18:1-6.*

We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary sexes together reflect the image and nature of God. Rejection of one's biological sex is a rejection of the image of God within that person. *Gen. 1:26-27.*

We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of the ministry. *1 John 3:14-15*

We believe the term "marriage" has only one meaning: the uniting of one biological male ("man") and one biological female ("woman") in a single, exclusive union, as delineated in Scripture. *Matthew 19:8 1 Corinthians 6:18, 7:2-5, Hebrews 13:4*

The above is the foundation for everything A Soldier's Child Foundation does and believes.

We as the board of directors believe we are tools in God's hand demonstrating his love to these special American children/families.
